Women in Numismatics Quiz

1. She has been editor of *The Numismatist* for more than thirty years.

- 2. She replaced Jeff Shevlin as executive director of the ANA.
- 3. She is the publisher for *Numismatic News*.

4. She was editor of Coin World from 1962 to 1985.

5. She was editor of *Coin World* from 1985 to 2012.

6. She was the first woman elected president of the ANA and served 1973 to 1975.

7. She was elected to the ANA Board in 1988 before her husband served as ANA President 2001 to 2003.

8. She served on the ANA Board 2005 to 2007. Her husband served on the ANA Board 2001 to 2005.

9. She was elected to the ANA Board in 2019 after her husband was ANA president 2015 to 2017.

10. She was convention director for the ANA until retirement in 2003.

11. She has been the FUN convention coordinator since 1993. She received the ANA Farran Zerbe Award in 2018.

12. She spent 14 months in the Buchenwald concentration camp and served as Executive Director of the National Numismatic Collection at the Smithsonian from 1983 until retirement in 2000.

13. She served as Director of the Mint 1961 to 1969, served on the ANA Board 1971 to 1975, and died at age 102.

14. She was a coin dealer and conducted numismatic auctions under the name of Coinhunter and died in 2017 at age 97.

15. She was the winning bidder for a 1794 silver dollar at over \$10 million.

16. She is a coin dealer known as "The Penny Lady."

17. The ANA School of Numismatics is named for her.

18. She wrote novels under the pen name, Monika Ferris.

19. The organization, Women in Numismatics, had three founding members. Name them.

20. She wrote the standard reference for one area of numismatics. Name the woman and the topic. Multiple answers possible.

Northwest Coin Club Evaluation Form for Judging Exhibits (Maximum Possible Points: 100)

1. Title and Scope (10 Points):

Does the title of the exhibit (and/or the statement of its scope, if included) clearly convey what the Exhibitor intends, by the exhibit, to show?

2. How well the exhibit tells a numismatic story (20 Points):

Does the exhibit relate coins, medals, or other numismatic items to a historic, economic, geographic, artistic

or other non-numismatic theme? Does the exhibit provide enough detail about the numismatic items to effectively tell the story? Put differently, to what extent has the Exhibitor achieved the goal set out in the exhibit's title and scope? ____20

3. Attractiveness (20 Points):

Is the exhibit neat, well designed, and eye-catching? Are the title and labels easy to read? Spelling and grammar count. __/20

4. Degree of Difficulty (10 Points):

Is the material shown common and frequently seen or is it unusual and not frequently available in the numismatic market? The cost of the material should not be considered. ____/10

5. Creativity, Originality (20 Points) :

Is the exhibit novel and imaginative in concept, content, scope, design, and presentation? $_/20$

6. Inspirational Capacity (20 Points):

Is the Exhibit likely to inspire others to pursue numismatics in general or the exhibit's topic in particular? ____/20
