## Lincoln Cent Set Sold

A few years ago, a donation was given to our club. This donation consisted of a complete Lincoln Cent collection starting from 1909 to 2007. All of the coins in the keys were included, 1909 S VDB, 1922 no D etc.

This collection was once again dusted off and brought to the fore while at the October MOON Coin Show 2021. The officers of the club decided that it was time to have closure to the



donation. Three different dealers at the show were approached to provide competitive bids on what they felt this collection was worth. The high bid was \$1800 from J&J Coins from Iowa. This quote to buy gave the Club the opportunity to sell the collection in the event a member did not come forward to buy. Next the members of our club were given the opportunity to purchase this collection instead. The 1922 was already graded, and the 1909 S VDB was not. This coin was sent to a grading service for authentication. The coin was given to Great Lakes Coins for submission, and it did come back authentic but with environmental damage.

Official bids were sent by silent bid to an impartial judge. Greg B. held the bids until the meeting in December as decided by the officers of the club. During the December meeting, it was announced that Bob H. had the winning bid of \$2200. He is expected to pick up the set at our January meeting.

If you are planning to display an Exhibit or a Numismatic Story Board at the 2022 Northwest Coin Club Spring Money Show, please be sure to submit your Application before the February 1, 2022 deadline.

### **Competitive Exhibits:**

Exhibiting is all about telling numismatic stories with coins, medals, tokens, currency, and all manner of exonumia. The exhibiting Format is flexible. Maybe you want to exhibit your collection in a traditional table top exhibit in one or more dealer cases. Maybe you have in mind an upright/vertical framed State Fair style exhibit on an easel. Either format is acceptable, and both will be judged together, with first, second and third place medals being awarded. There will also be a "peoples choice" award for the most popular exhibit selected by Show attendees.

#### New this year: The Numismatic Story Board, A non-competitive alternative

Do you want to share your numismatic knowledge, but don't want your coins to compete with those of other collectors, or perhaps you don't *have* the coins needed to fill out a traditional exhibit. A tri-fold, vertical, "science fair" style triptych might be the answer. This year, the Northwest Coin Club (NWCC) has created a new category of information sharing, we call, "The Numismatic Story Board."

With or without coins, you can share a coin related narrative to inform and entertain. The Numismatic Story Boards will not be judged, and are therefore not eligible for awards.

At the December meeting, Dave M. provided the historian with a badge from the 1961 Central States show hosted by the Northwest Coin Club. I did not know that there were two forms of the badge. The one with the hanging medal is familiar. The one with the sawtooth bottom is a new discovery (for me).

Glenn S. was Glenn Smedley, a well-known member of the ANA. The ANA Glenn Smedley Memorial Award is named for him.

Mrs. E. Cedarleaf was Emma Viola Cedarleaf, widow of Evar T. Cedarleaf. He died in 1959 and she joined the ANA in 1960 as member #35270. She was not known to be a member of the Northwest Coin Club.
